PIAA ANNOUNCES TEAM WRESTLING CHAMPIONSHIPS SITE

MECHANICSBURG – The Pennsylvania Interscholastic Athletic Association, Inc. (PIAA) is pleased to announce Altoona Area High School Field House, Altoona, PA as the site for the 2025 PIAA Team Wrestling Championships. Championship Rounds will occur on Friday, February 7 and Saturday, February 8, 2025.

With the change in location, the PIAA Wrestling Steering Committee unanimously recommended a change in format, which will provide for Preliminary and First Round Competition to take place regionally on Tuesday, February 4, 2025. The eight regional winners in both AA and AAA of those First Round matches will advance to Altoona Field House for a double elimination tournament, beginning with the Quarterfinals, through Championship Finals and Consolation Finals.






